- 3.0 Review HEART-SV's Proposal to Finance and Acquire 417 Stambaugh St (the "Project") for the Acquisition and Preservation of an 8-unit Building in the City of Redwood City.
 - 3.1 **HEART-SV Ad-Hoc Property Acquisition Committee ACTION**: Recommend to the HEART-SV Board that it authorize staff to:
 - 1) Remove the due diligence contingency in the Purchase and Sale Agreement making the \$50,000 earnest money nonrefundable, and
 - 2) Proceed with the financing and acquisition of 417 Stambaugh, authorize the Executive Director, the Board Chair, and/or the Board Vice Chair to execute any and all loan agreements necessary with the Bank, the City of Redwood City, and/or HEART to carry out the financing and acquisition of the project, execute any and all agreements necessary to acquire and operate the property, and record the rent regulatory agreements restricting the rents of the units.
 - 3) This authorization shall be contingent on obtaining suitable property insurance.
 - 3.2 **HEART Loan Committee ACTION**: Recommend to the HEART Board that it:
 - Approve a 55-year loan for up to \$1.9 million in LHTF funds at 3% interest; if needed, a 10-year loan for up to \$555,000 in HEART Trust Funds at 4.5% interest; and if needed, a 3-month bridge loan for up to \$1 million in HEART Trust Funds at 4.5% interest in the event there are any delays in the funding of the City of Redwood City loan; and
 - 2) Authorize the Executive Director, the Board Chair, and/or the Board Vice Chair to execute any and all documents necessary to provide the loans.
 - 3) This authorization shall be contingent on obtaining suitable property insurance.
